## MEMBERSHIP RIGHTS AND RESPONSIBILITIES

### MEMBERSHIP BENEFITS

- Members of Community First will receive copies of the newsletter **First News**, discounted rates for all services, training or events for which Community First charges (including the meeting room), and the opportunity to participate in the governance and policy making of a dynamic and forward looking charity.

### VOTING RIGHTS

- Group members will be asked to nominate a delegate from within their own organisation to a vote on their behalf on matters raised at the AGM.
- Individual members will be able to vote in their own right on their own behalf.
- Delegates and individual members may be nominated for election to the Executive Committee (Board of Trustees).

### MEMBERSHIP RENEWAL

- Membership will run from the 1st April to the 31st March. Membership renewal notices will be distributed in the first quarter of each calendar year. Memberships taken up from 1st January - 31st March each year will continue until 31st March the following year.

### GUARANTORS

- Consistent with the requirements of the Charity Commission and company law, members are required to give their written consent to act as Guarantors. In the unlikely event of the liquidation of the company a Guarantor may be requested to make a payment of not more than £1.00.

*Every member of Community First undertakes to contribute to the assets of the company, in the event of the same being wound up while he/she is a member or within one year after he/she ceases to be a member, for payment of the debts and liabilities of the company contracted before he/she ceases to be a member, and of costs, charges and expenses of winding up, and for the adjustment of the rights of the contributories amongst themselves, such amount as may be required **not exceeding £1.00.***
